Terms & Conditions Sponsoring

General

1. These Terms & Conditions of sponsorship apply to ECPC
2. The applicability of the ECCPC sponsors general terms and conditions do not apply to the legal relationship between the organizer on the one hand and the sponsor on the other and are expressly rejected.
3. Unless otherwise agreed in writing, a sponsorship agreement ends by operation of law and therefore without any notice being required after the ECPC has ended. Except in the situations set below, the sponsorship agreement can not be terminated prematurely by the sponsor.
4. Unless otherwise agreed in writing, the organizer is entitled to attract other (main)sponsors for the ECPC in addition to the sponsor.

Payment

6. Payments for ECPC sponsorship are to be made as follows. At invoicing for sponsorship of the event, the deadline as stated on the invoice must be strictly observed. In case of late or incomplete payment of the invoiced amounts, the sponsor will owe a contractual interest of 1% per month on the amount not paid on time, whereby part of a month counts as a full month
7. Unless otherwise agreed in writing, payment of the fee must be received by the organizer no later than 1 (one) month after the date of ECPC.

Cancellation

11. The organizer reserves the right to change the date set or cancel the ECPC at any time. In the unlikely event that the organizer exercises that right, the sponsor is not entitled to fulfillment of the agreement by the date originally agreed, nor is the sponsor entitled to compensation for damage suffered and to be suffered, however named and based on whatever.
12. If the organizer is forced to cancel the ECPC, or in case the organizer is no longer entitled to organize the ECPC, (of which the organizer will inform the sponsor in advance if possible) the organizer will not owe the sponsor any compensation for damage or otherwise in this regard.
13. Unless expressly agreed otherwise, the sponsor agreement cannot be terminated prematurely.
14. Cancellation of ECPC sponsorship and/or the underlying agreement(s) must be communicated to the organizer in writing stating reasons and is only permitted with the prior written consent of the organizer. If the organizer agrees to such cancellation, which it can never be obliged to do, the organizer reserves the right to demand payment of the full invoice amount.
15. Notwithstanding Article 13, the Sponsor Agreement can be terminated by both parties prematurely and without judicial intervention with immediate effect and without prejudice to its right to compensation if:
 16. the other party has applied for a moratorium, goes bankrupt or its legal entity is dissolved;
 17. the other party fails to perform any substantial obligation under the Sponsor Agreement and does not remedy its default within the reasonable period of time set for that purpose.

Intellectual property

16. For promotional purposes for the ECPC, the sponsor will make its logo/brand available on the first request of the organizer. The intellectual property of logos remains with the sponsor.
17. Sponsor has no control over the way the organizer promotes ECPC.
18. Sponsor is permitted to use the organization's logo (including references to the website) in relation to the event.

Liability and insurance

19. The organizer is never liable for damages, however based or however named, arising out of or related to the participation of sponsoring ECPC. De Organisator is nimmer aansprakelijk voor schade waar dan ook op gebaseerd of hoe dan ook genaamd, die voortvloeit uit of samen hangt met de deelname van Sponsor aan het ECPC. This excluded damage in any case includes, but is not limited to, damage to property or persons, financial loss and consequential damage.
20. Each sponsor is obliged to insure itself on and around the days of the event and keep itself insured against the consequences of legal liability and is liable to the organizer and other parties for all damage that it, its personnel or third parties under its responsibility participating in the ECPC directly or indirectly on the organizer or third parties. Sponsor will indemnify the organizer at first request against all claims by third parties in this regard and will indemnify the organizer for all damage suffered and to be suffered by the organizer in this respect as well as costs incurred and to be incurred.
21. Each sponsor is obliged to take adequate measures to prevent items belonging to it, on loan or otherwise made available to it from being stolen, destroyed, damaged or otherwise impaired (in value) during the event and is obliged to adequately insure and keep insured items during that period, insofar as they are not insured by other parties.

Applicable law

22. The agreement between the organizer and the sponsor is governed by Dutch law. All from this agreement ensuing disputes, even those that are only regarded as such by one of the parties, will be assessed by the competent court in Groningen.
